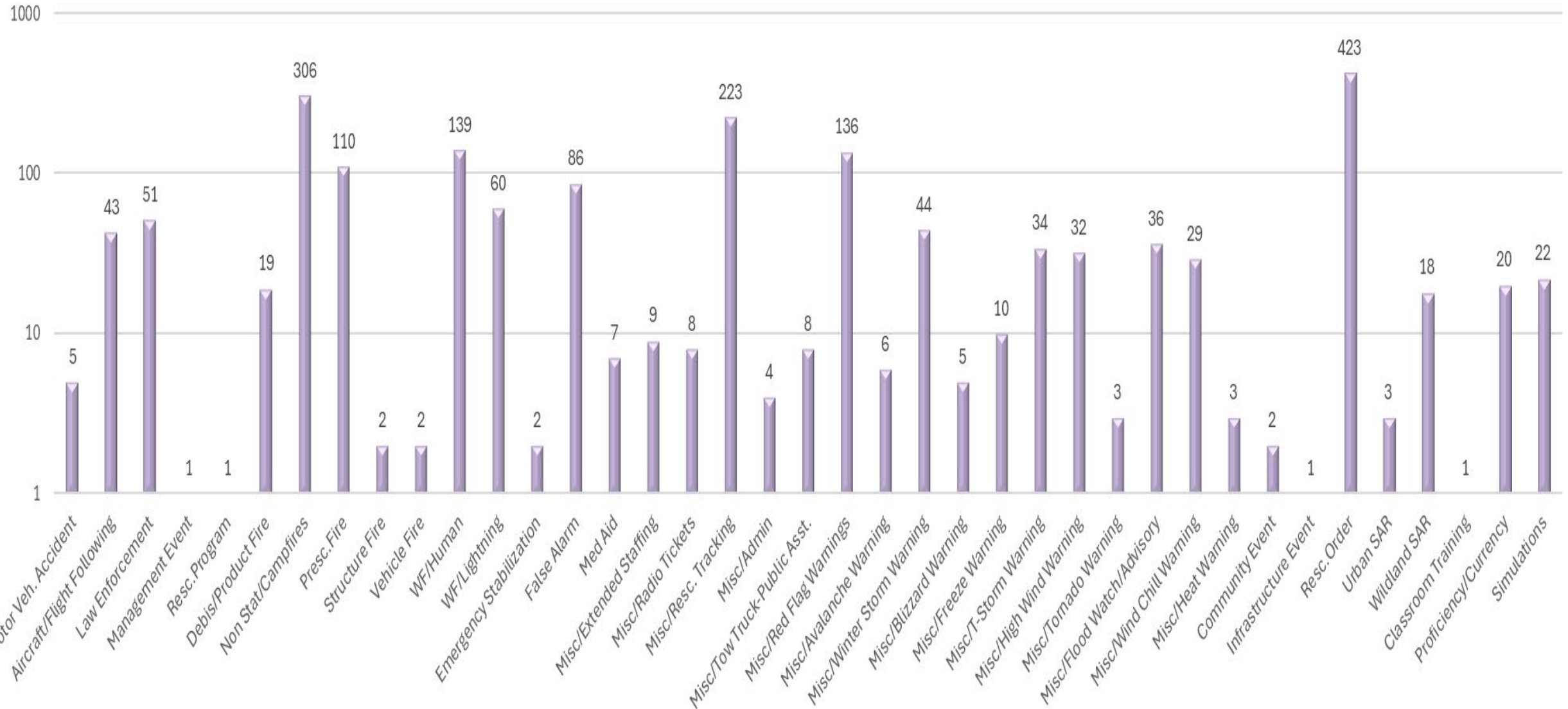

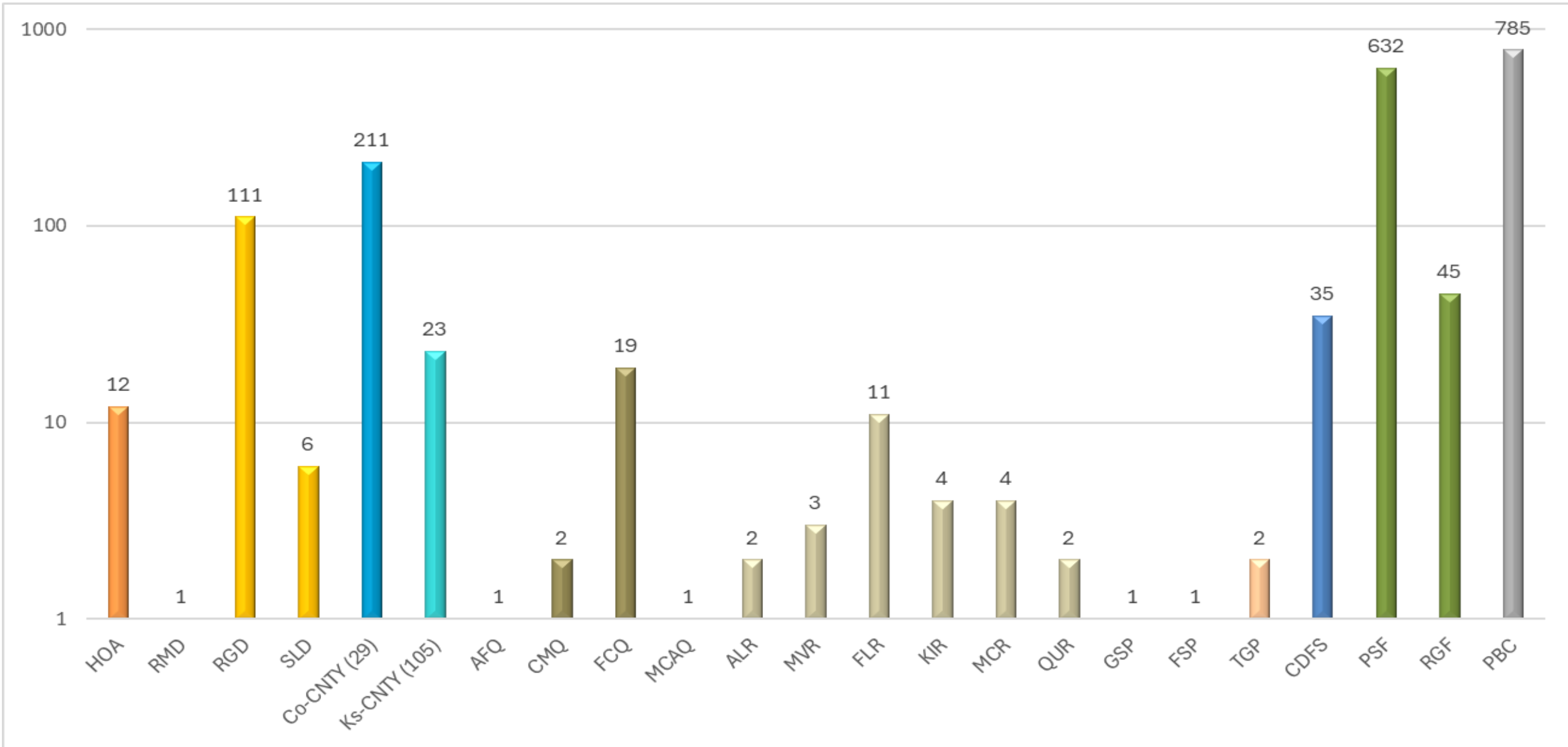
Narrative

- The 2024 season for Pueblo Interagency started off with our first large fire 209 on Feb. 13, 2024, for 400ac in Kansas. This led to a normal season with warm and dry conditions for most of the zone, but low fire numbers. The early season seemed to be a normal start, had fires on the military base of Ft. Carson in early February that went for 7000ac. We didn't see much of for large fire until Jun 11th, 2024, when the Interlaken fire started. This fire was notable due to its location at 10,000ft and it when for 704ac, and was kept at a type 3 org. Then ten days later the Oak Ridge Fire was started by lightening and this fire was our first and only CIMT for the year. This year seemed to be average year, but we managed to increase fires and acres within the zone. This years YTD stats was 199 Fires for 46,207ac, and 90 RX's for 15,276ac. With the actively of locally the Pikes Peak RD on the Pike National Forest was able to pull off a RX in the summertime frame of the season. The Monument Fire Center RX happened in June of 2024 and was able to meet the objectives that are lined out in the plan and accomplished a total of 646ac. Again, this was the first mid-summer RX completed within the dispatch zone.
- Also, in the center this past year we saw an increase in the staffing of DFPC in the dispatch center. This year we welcomed a Deputy Center Manager Tiphaine Barter, and two IA dispatchers- Joshia Martinez and Amy Thompson. With these folks coming on board the state of Colorado has brought a total of 5 dispatchers to the center. Also, the forest service brought on a Resources Intern into the center. Hope Lopez is part of the USFS RAP program and will be completing a 9-12 internship with the center. After that she will have the skills and experience to join the team if she desires. The center is increasing staff as part of the 2018 dispatch consolidation study. The FS side of the center has two new positions starting in February of 2025 and will bring the numbers in the center up to 15 staff. We are still looking to fill the BLM position in the center and hoping 2025 is the year for that.
- With the increase in staffing numbers this has given the entire staff the opportunities to go on training assignments. Support the local, GACC and National shortages of dispatchers. The staff did assignments in Ft. Collins, Rocky Mountain Coordination, two center and the NICC in Idaho, Casper, WY, Tennessee, and California. Also support the RMA in the way of a Virtual expanded as needed.

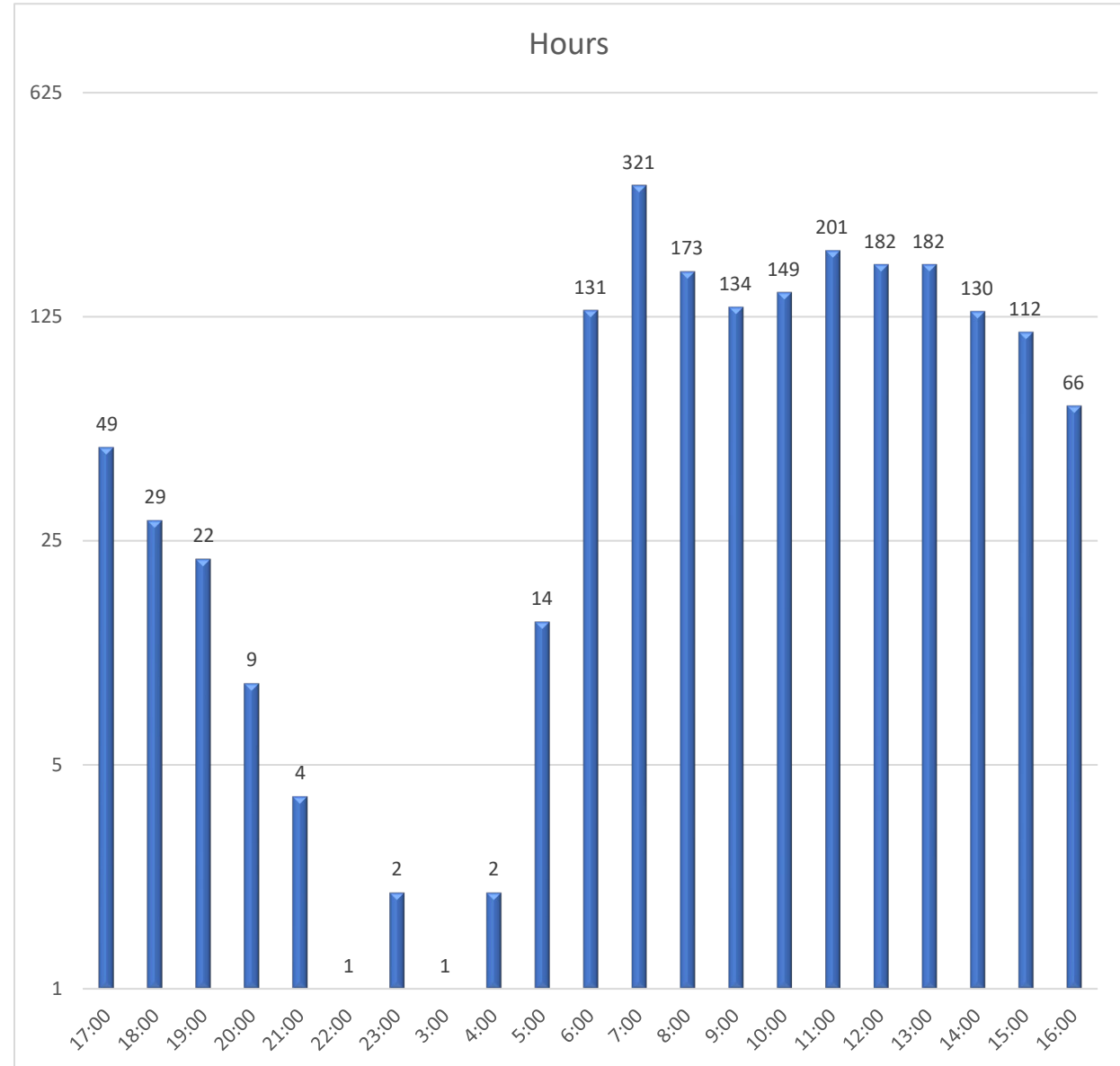
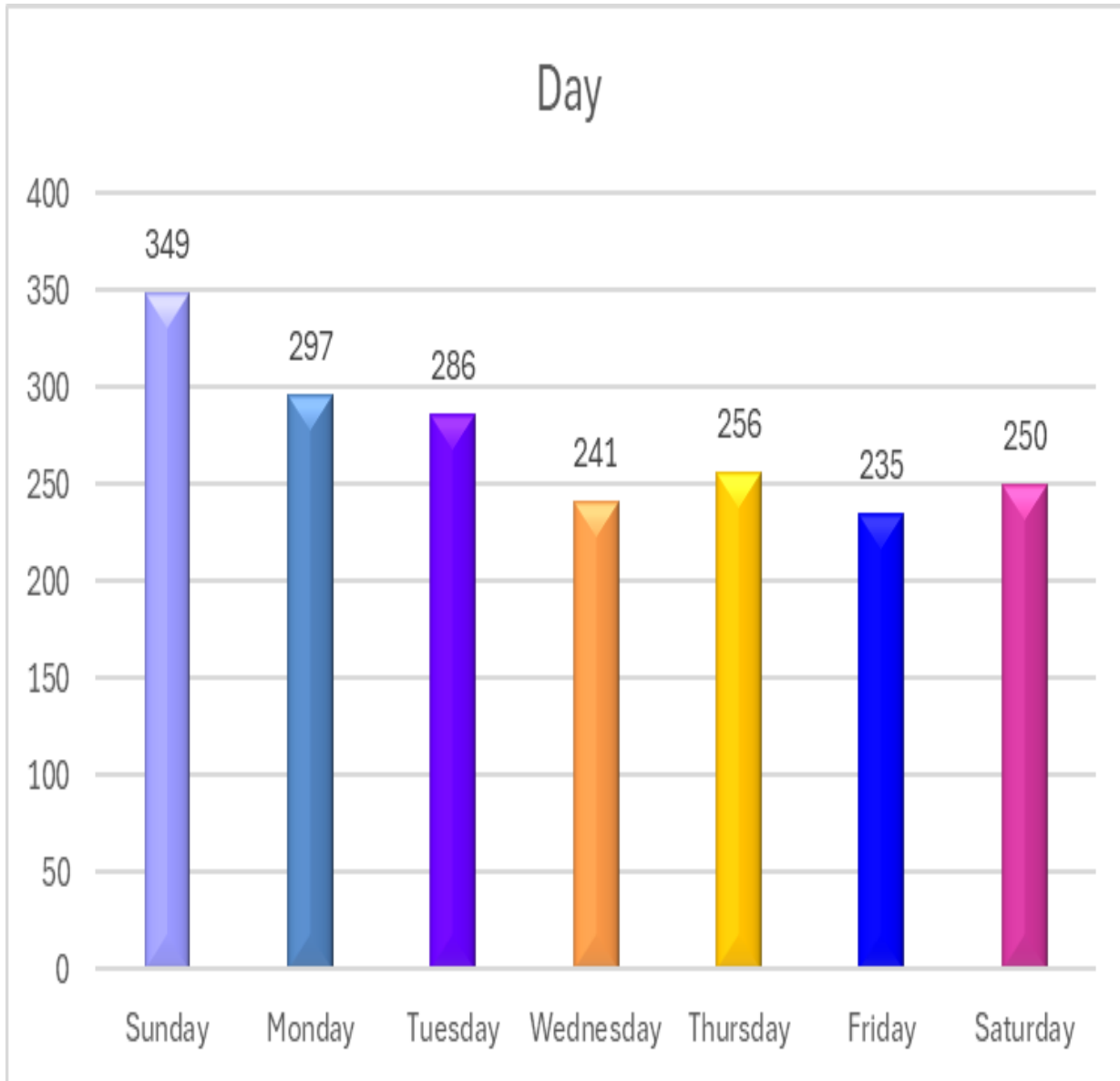
Incidents By Type: 1,914



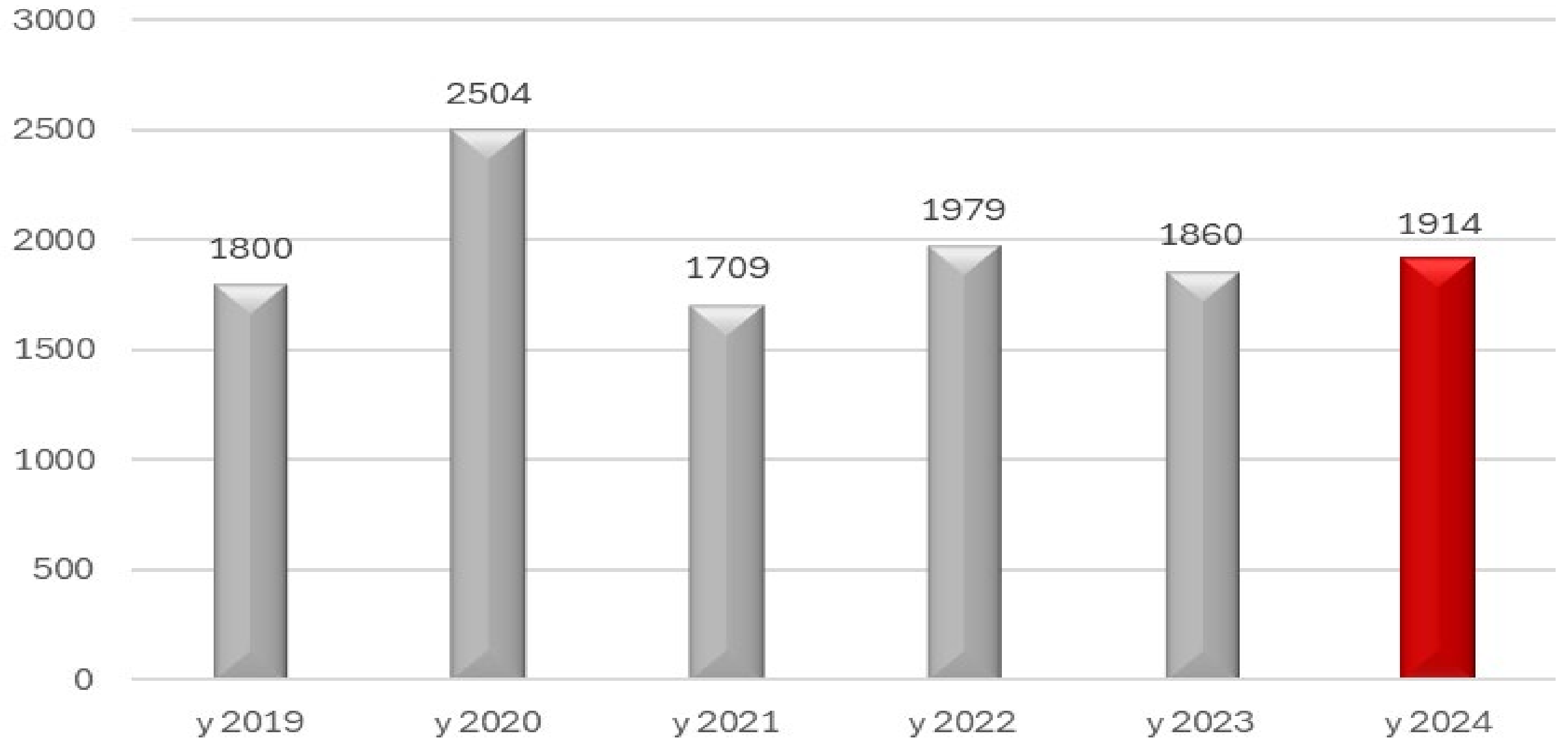
Incidents By Agency: 1,914

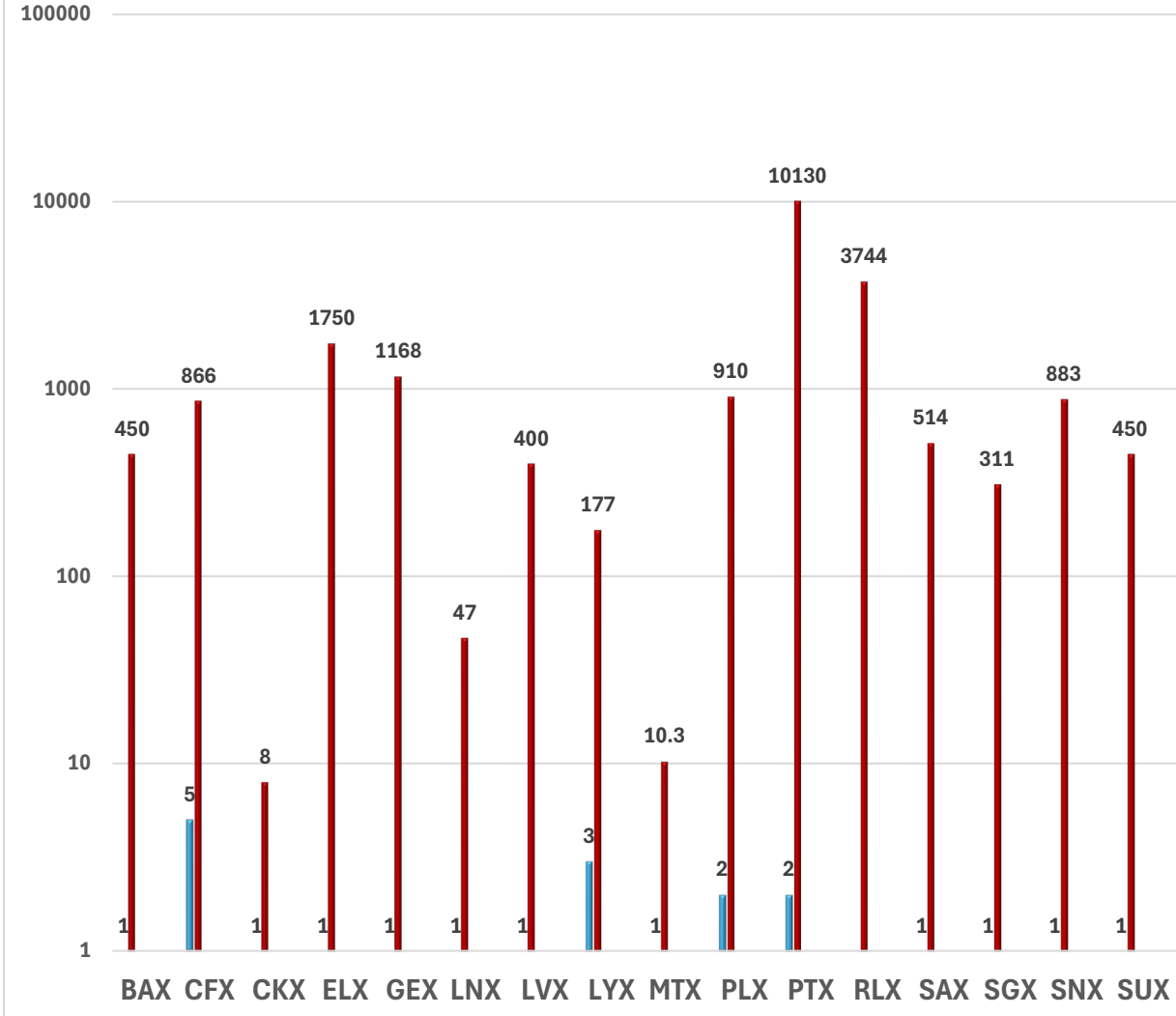

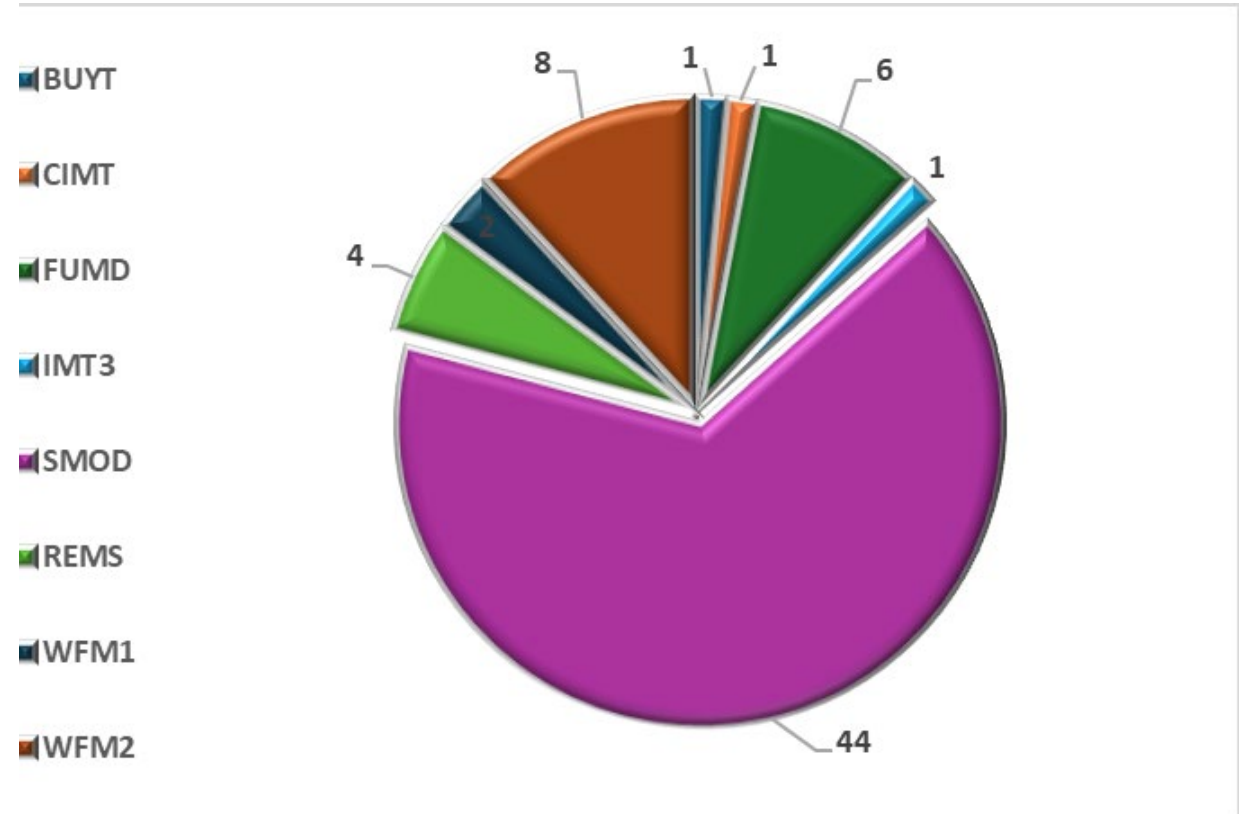
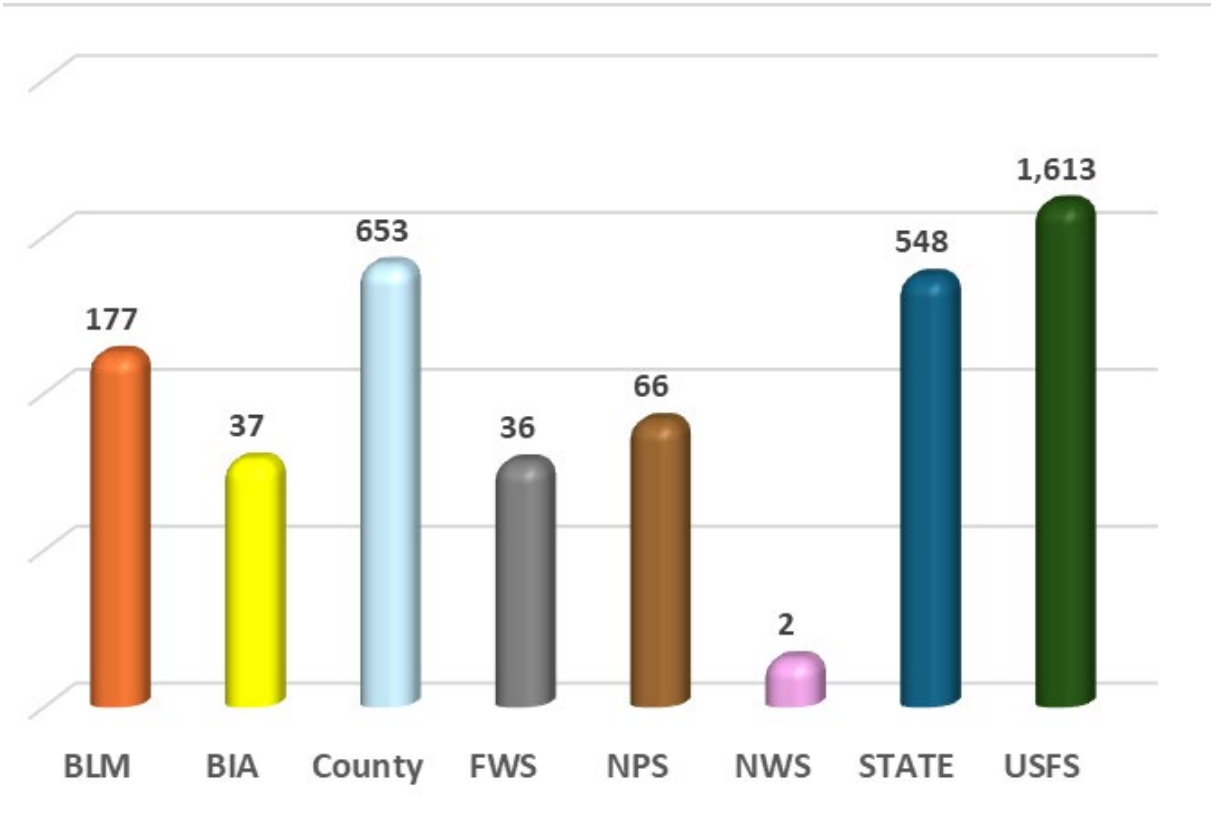
Fires & Acres by Month



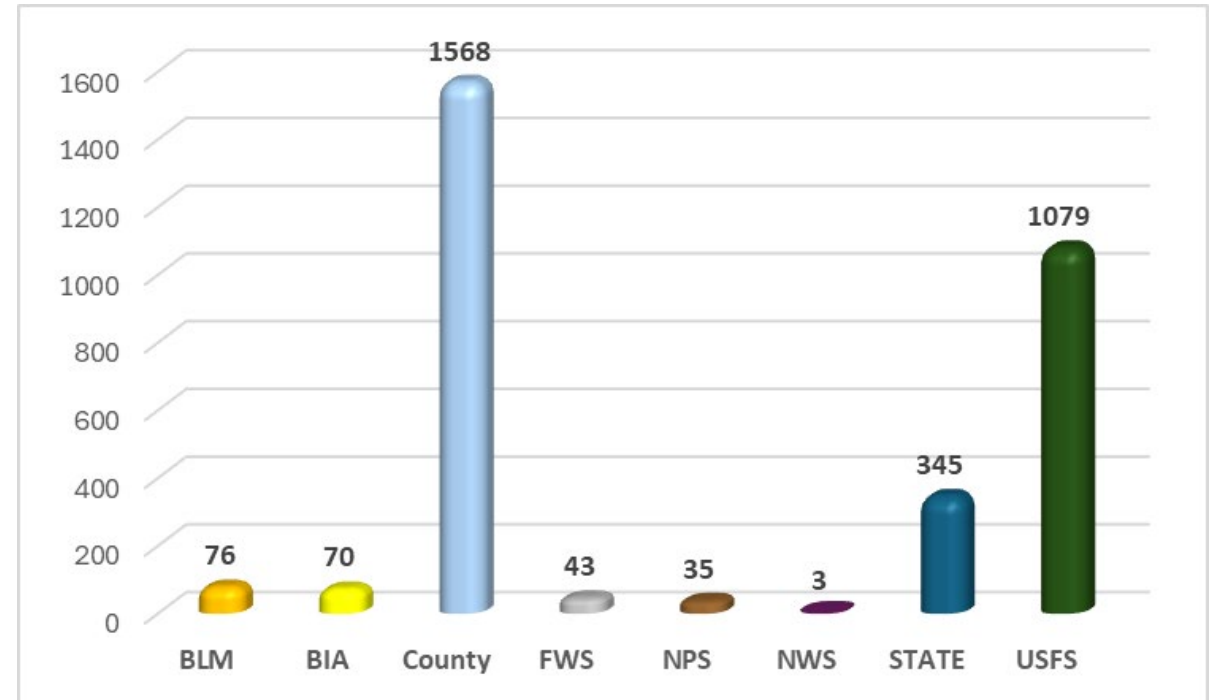
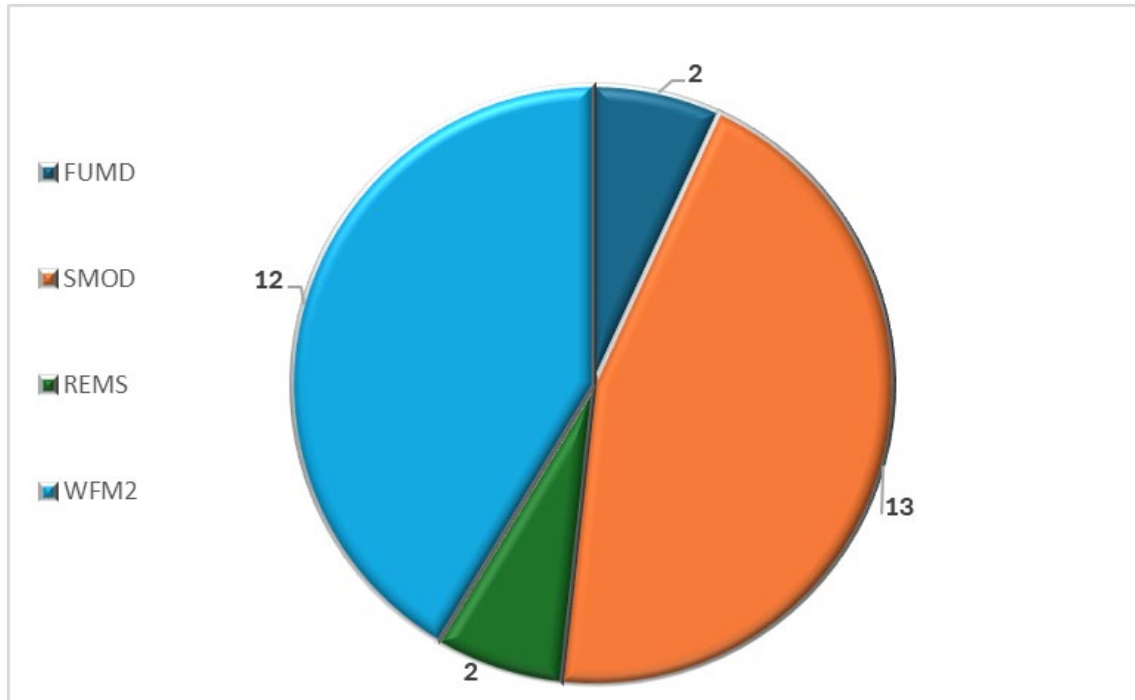

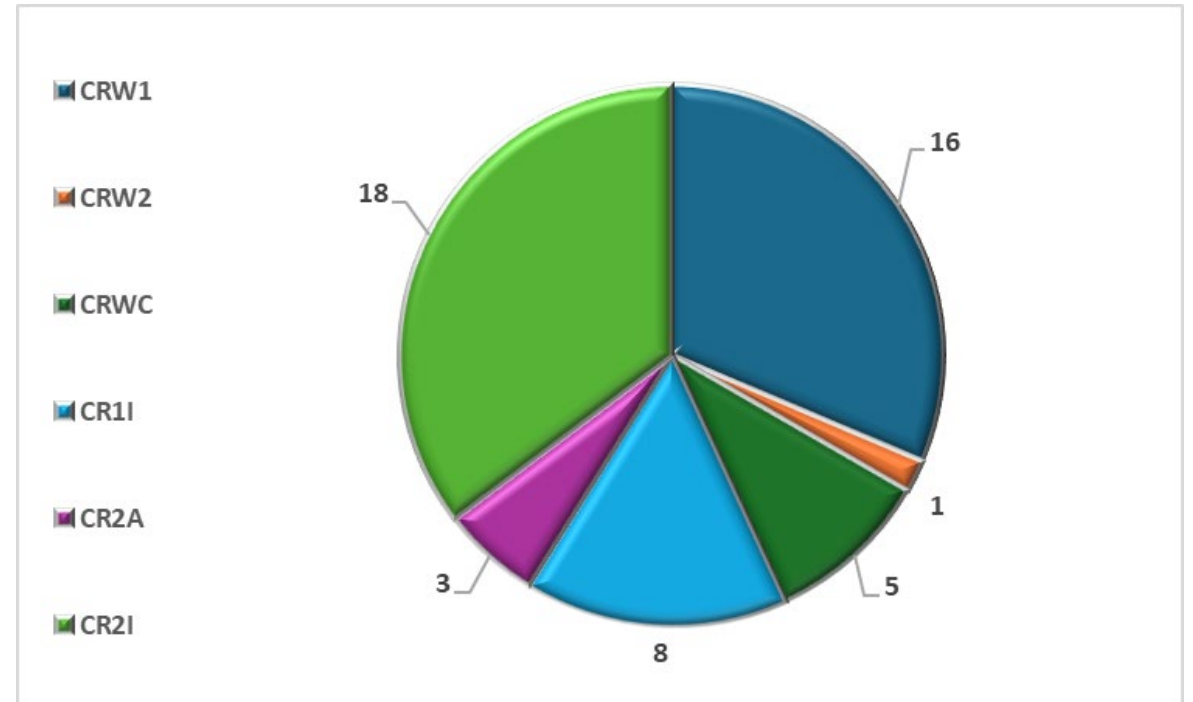
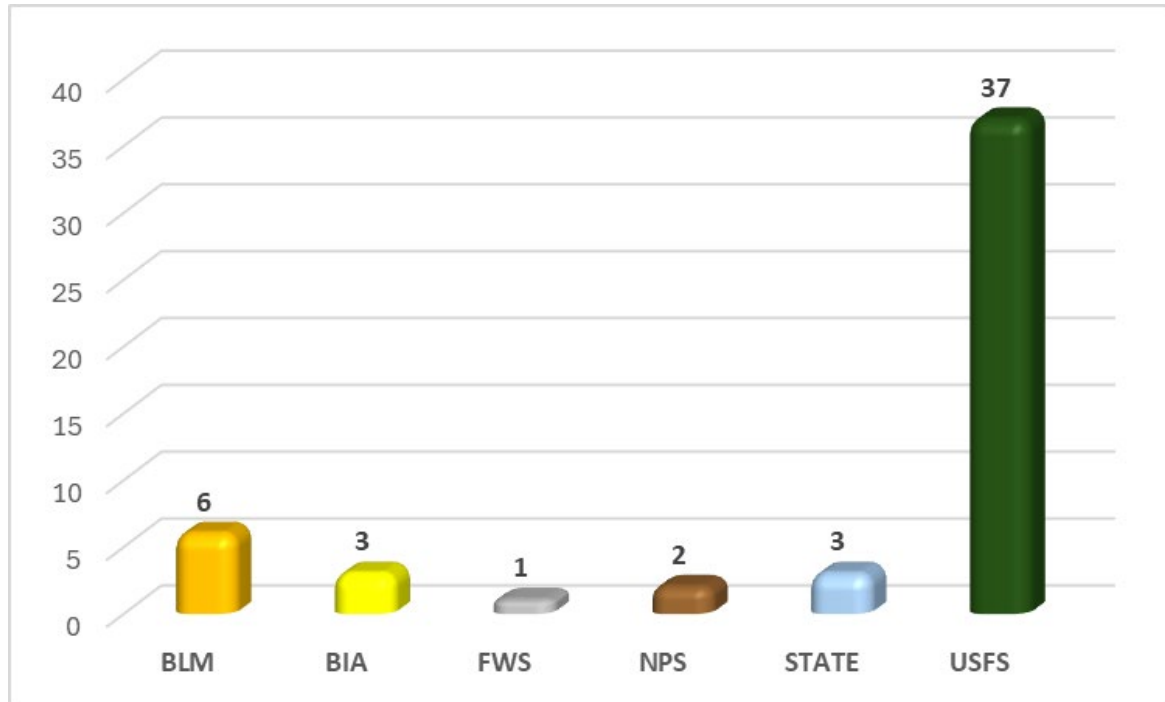
Overhead In Zone: 3,132 for 65 Incidents



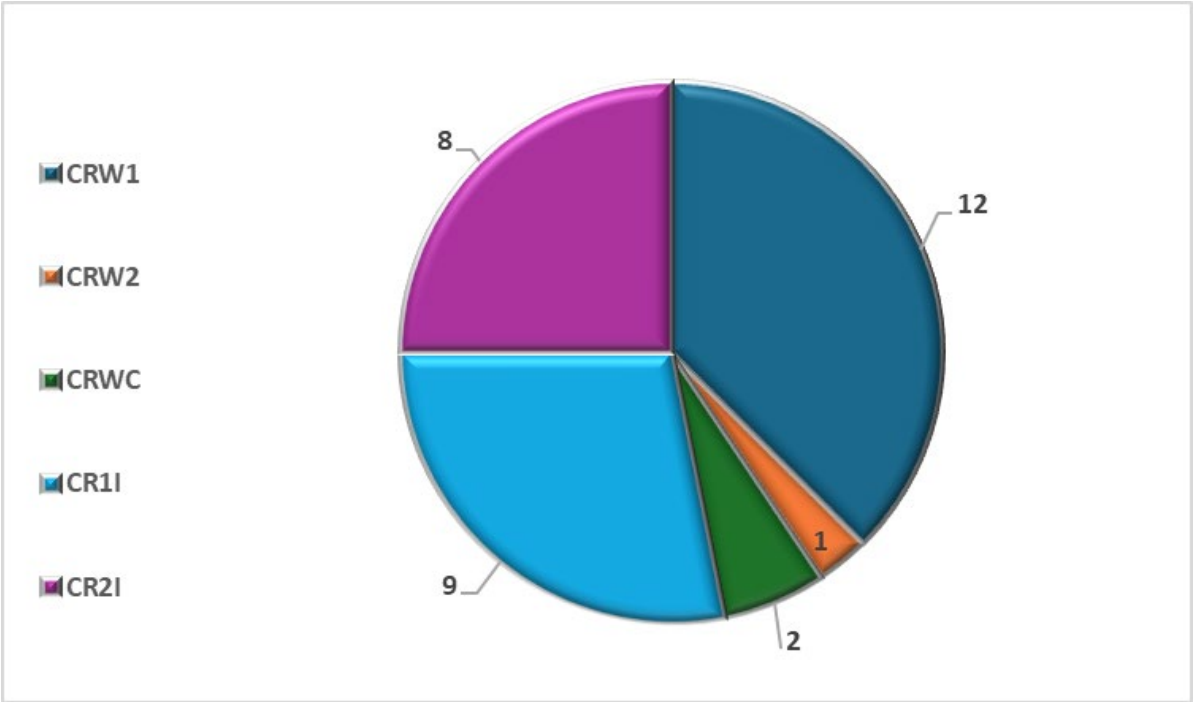
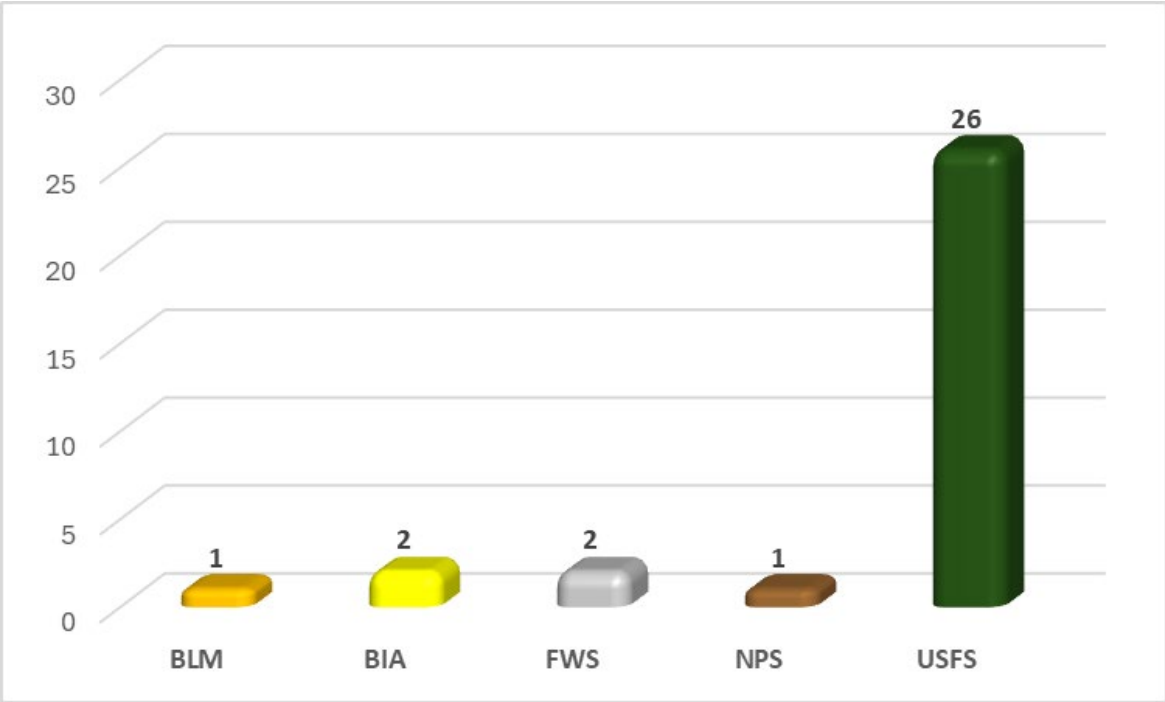
Overhead Out of Zone: 3,219 for 374 Incidents



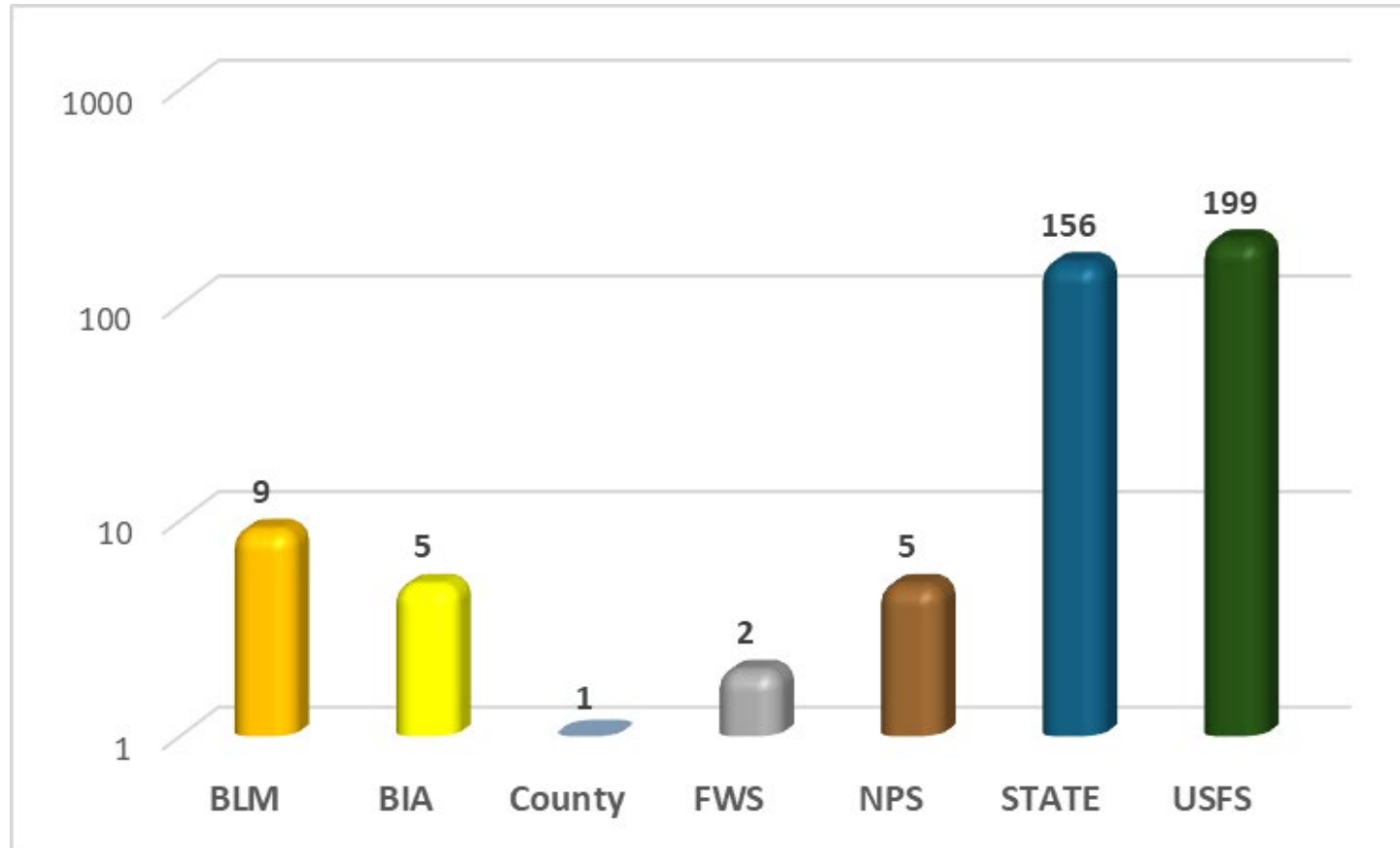
Crew In Zone: 52 for 9 Incidents



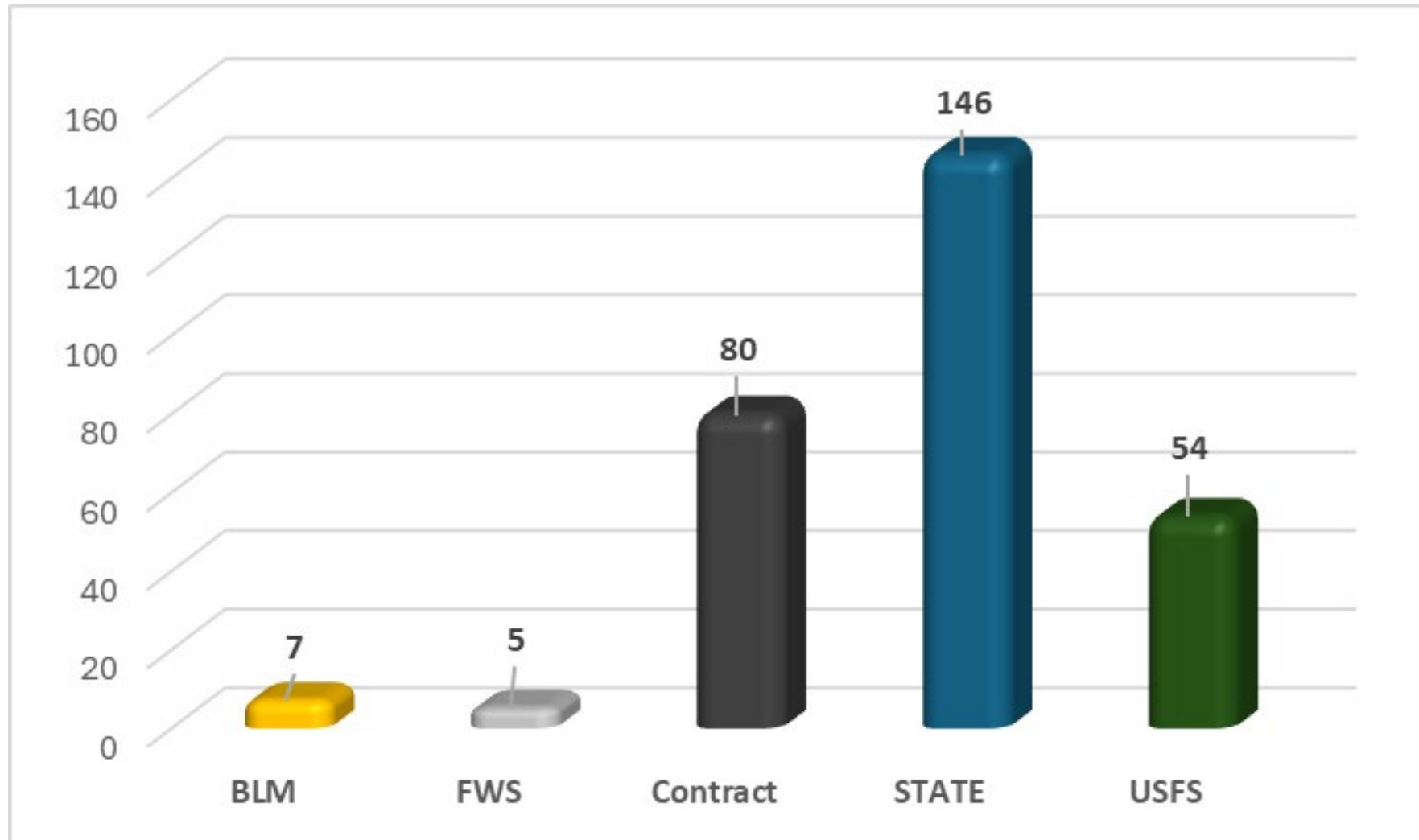
Crew Out of Zone: 32 for 19 Incidents



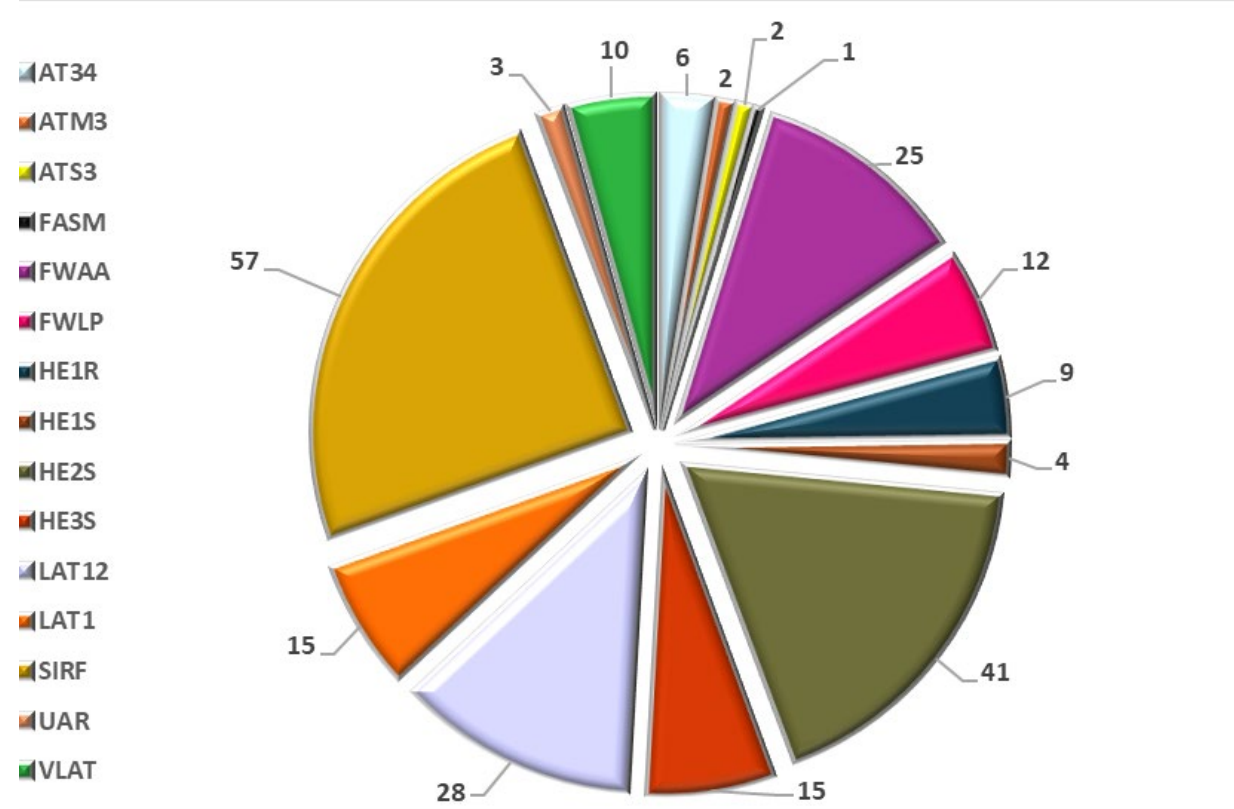
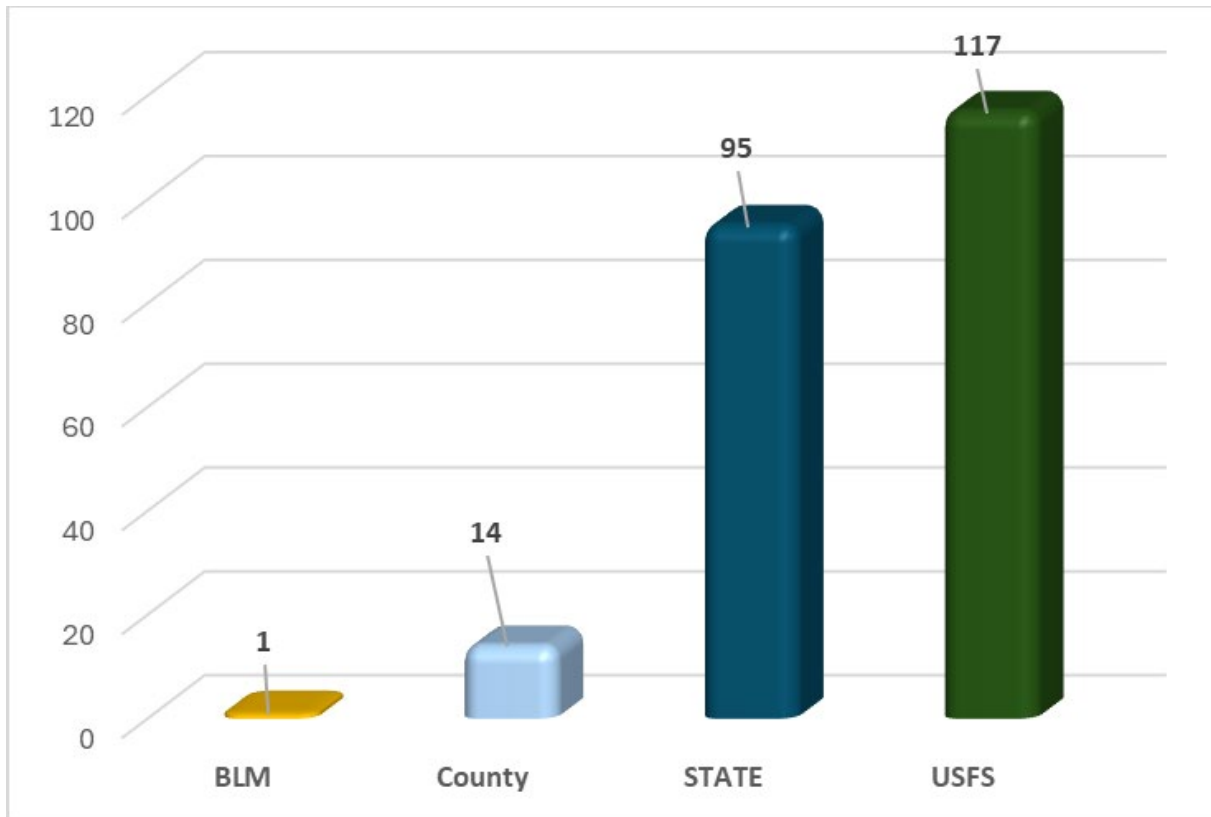
Equipment In Zone: 377 for 24 Incidents



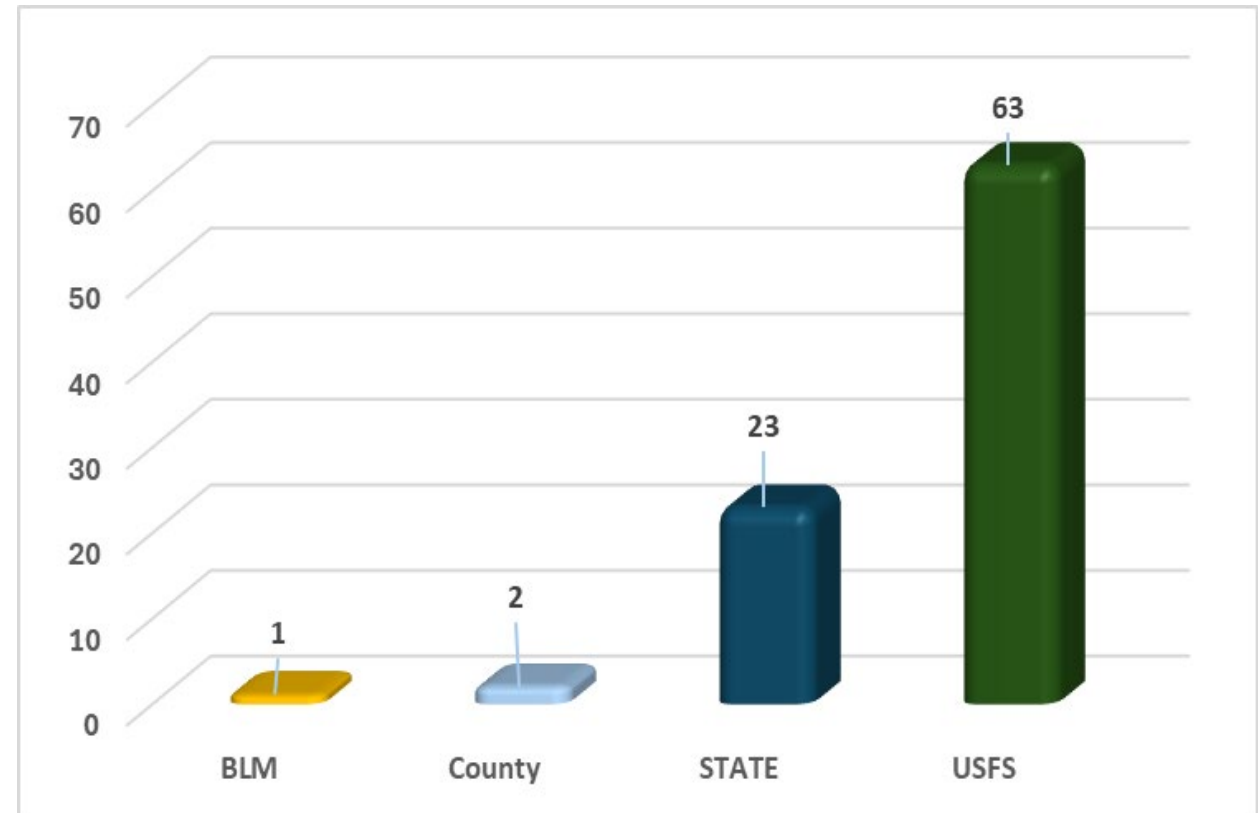
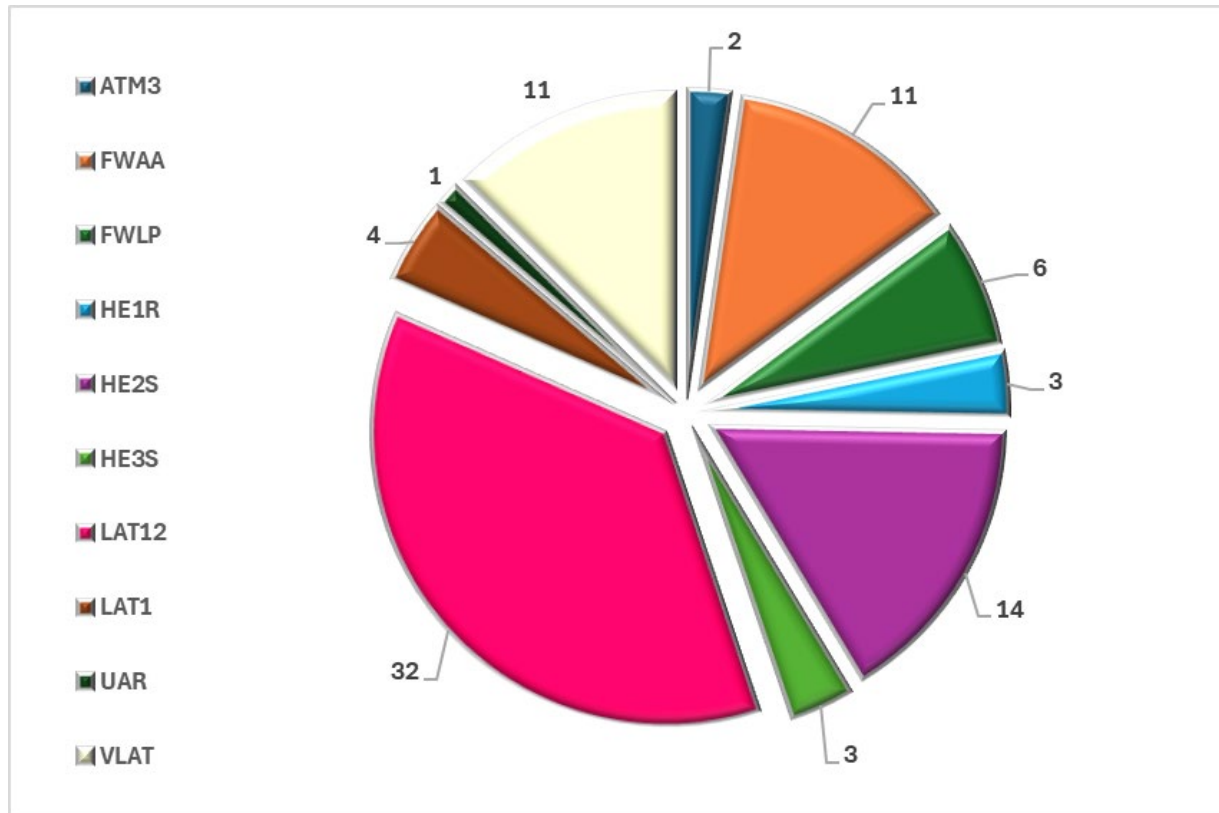

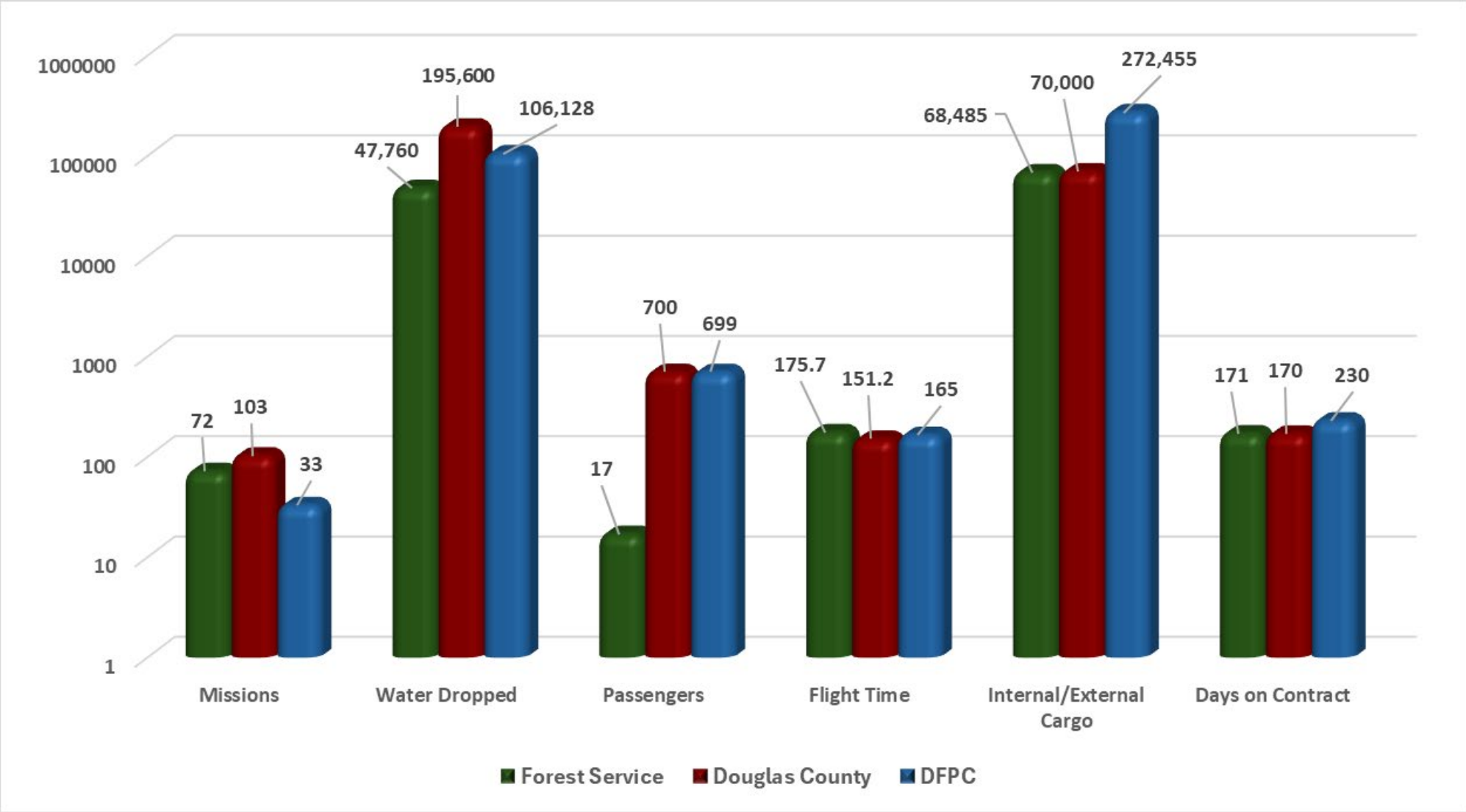
Aircraft Out Zone: 89 for 50 Incidents



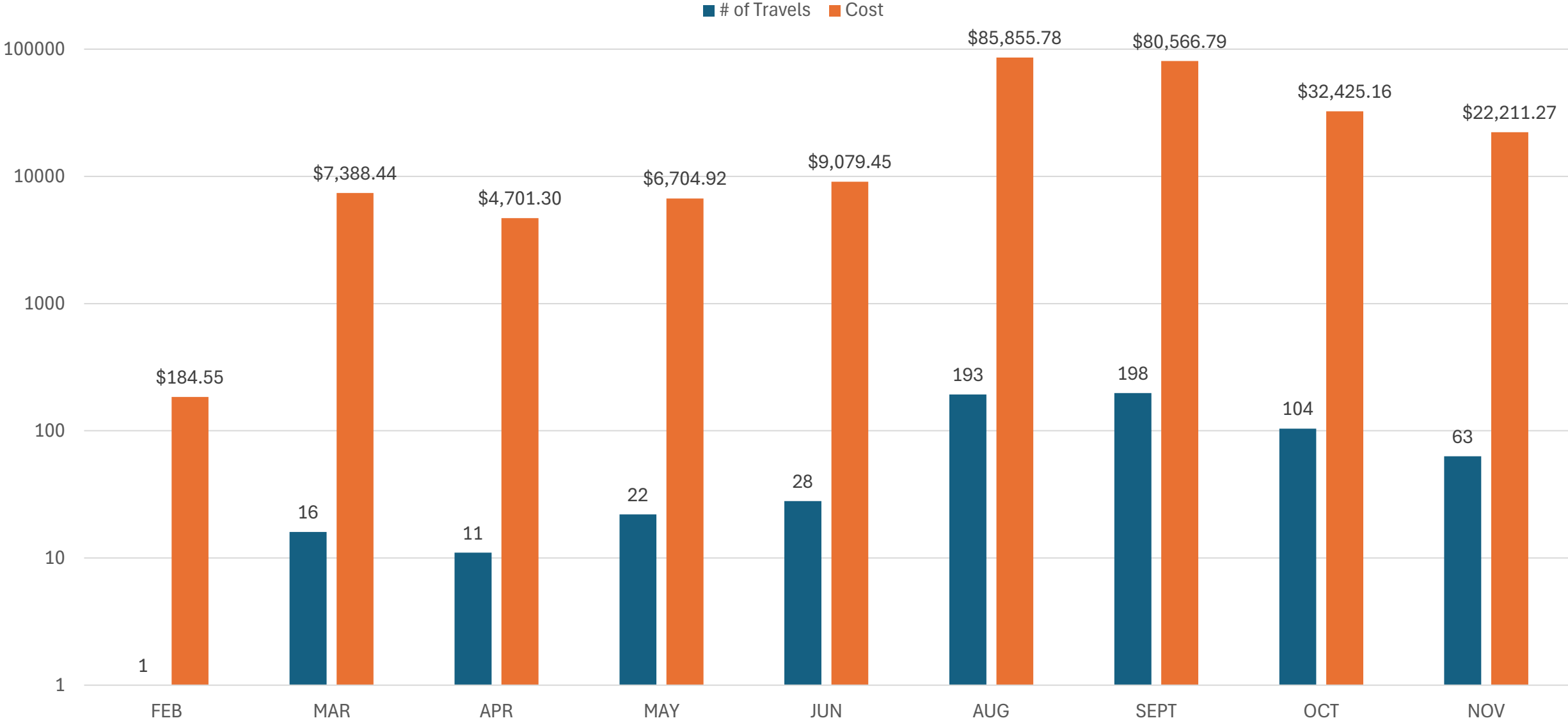
