## 2017 Southern Area Fire Weather


The year of 2017 began with a weak El Niño signature in the tropical Pacific. This warm anomaly began to fade in August and the tropical waters of the Pacific remained in a cold bias for the remainder of the year. This signature, along with a number of other oscillations on a hemispheric and/or global scale, has a significant influence upon weather conditions in the Southeastern United States.

January featured above normal rainfall for most of the Southern Area with the exception of Florida, Deep South Texas, and the Mid-Mississippi River Valley. Oddly enough, by the end of January 2017, the wettest areas were western Texas and western Oklahoma.

However, during February the dryness began to build over the Carolinas and Virginia as well as the Lower Mississippi River Valley. Dryness expanded during March to include most of the Southern Area except western Texas and Oklahoma. This trend continued into June and July where many areas recovered somewhat. Texas in particular began to show some drying in July which was moderated by Hurricane Harvey somewhat in August. This mixture of above normal and below normal precipitation continued to be the case for the balance of the year with much of the Southern Area registering year-to-date deficits by the end of December. Western Texas, the Gulf Coast from Corpus Christi, Texas to Mobile, Alabama, and central and southern Florida were the notable exceptions, ending the year with surpluses of rainfall.



## 2017 Hurricane Season



Hurricane Harvey made landfall as a Category 4 Hurricane near Rockport, Texas on August 25. Harvey was the first major hurricane to make landfall on the United States since 2005. Rainfall totals exceeded 60 inches which resulted in extensive flooding in the Houston metro area. Harvey's unusual track inland, followed by a re-emergence into the Gulf of Mexico, followed by a second landfall in southwest Louisiana on August 30 was unique in many aspects. This unique track was at least partially responsible for the flooding that occurred. Harvey's winds at landfall were 132 mph near Corpus Christi, Texas, but only 46 mph on the coast of southwest Louisiana. Harvey finally dissipated near Frankfurt, Kentucky on September 2, but lost tropical storm status while still in Louisiana.

Hurricane Irma moved very close to the US Virgin Islands (USVI) on September 6 as a Category 5 Hurricane with winds to 184 mph with gusts to 205-210 mph. Irma was one of the most powerful Atlantic storms on record and formed just west of the Cape Verde Islands. Irma caused extensive damage on St. John, USVI and some damage on St. Thomas, USVI as well. Irma wind field clipped the northeast corner of Puerto Rico and did some damage on that island as well, even though its track took it over the open waters to the northeast of Puerto Rico. Hurricane Irma, also a Category 4 Hurricane, made landfall on Cudjoe Key, Florida on September 10 with winds to 132 mph. Irma's strong winds and storm surge are held accountable for destroying 65% of the buildings in the Florida Keys. Irma's track took it northwest across the Florida Peninsula, across southwest Georgia, and finally dissipated near the junction of Alabama, Tennessee, and Mississippi on September 12. Irma remained a hurricane as far north as Brooksville, Florida and it remained a tropical storm as far north as Columbus, Georgia. Irma's peak winds were listed as 184 mph and with a central pressure as low as 914 millibars.



The third hurricane of note was Maria, which formed in the tropical Atlantic to the southeast of the Windward Islands. Maria intensified rapidly from 52 mph on September 16 to 175 mph on September 19. Maria tore across the island of Dominica on September 18 with winds of 161 mph, devastating 95% of the structures on the island. Maria continued as a Category 5 Hurricane as it moved toward the U.S. Virgin Islands and Puerto Rico. Rain bands first approached St. Croix, USVI, as well as portions of St. Thomas, USVI and St. John, USVI during the morning hours on Tuesday, September 19th. Maria made it up to 175 mph that Tuesday evening, and its eye wall missed St. Croix, USVI by about five miles. Maria's eye wall did travel over Vieques, Puerto Rico early that morning. Maria made landfall in Puerto Rico with winds of 155 mph on September 20. Category 5 strength begins at 156 mph. Maria's northwest track across the island of Puerto Rico caused widespread devastation to transportation, agriculture, communication, and energy infrastructure and was the strongest hurricane to impact Puerto Rico since 1928. Maria's track kept it north of Hispaniola, just east of the Bahamas, and east of the CONUS. Maria finally turned eastward off the coast of North Carolina on September 27 and remained a powerful extra-tropical storm in the mid-Atlantic through October 2. Maria's peak winds were listed as 173 mph and with a central pressure was as low as 909 millibars. Maria is the 10th most intense hurricane categorized by pressure in the Atlantic basin.

Hurricane Nate made landfall on the southeast "toe" of Louisiana on October 7 with winds to 86 mph and then a subsequent landfall on the coast of southern Mississippi on October 8. Nate formed in the warm waters off the coast of Nicaragua on October 4 and finally dissipated in western Pennsylvania on October 9.

## Preparedness Level Review

The first Preparedness Level (PL) change occurred towards late February into PL 2, about a month ahead of the 5 year average. With fire activity continuing to increase in multiple areas throughout the Southern Area, the PL increased in March and throughout April up to PL 3.

Fire Activity in the Southern Area minimized towards the summer months of May through August, but due to the emergency responses during the Hurricane Season and western mobilization, PL increased to 5. The PL remained at PL 5 for 20 inconsecutively days before quickly dropping back to PL 1 before year end.



### Fire Summary for the Southern Area

Fires reported in the Southern Area were above the 5-year average for fire occurrence and total acres burned during 2017. As of December 31, there were 35,068 fires reported, burning a combined total acres of 1,960,764. This data came from the Fire and Aviation Management Web Applications Program (FAMWEB).




### Historical Southern Area

The 2017 fire season was 93 percent of the Southern Area 10-year annual average for wildfires reported. There were 35,068 wildfires reported in the Southern Area (compared to 33,504 wildfires reported in 2016). The number of acres burned was well above normal in 2017 with 1,960,764. Large fires that burned across the Southern Great Plains in Oklahoma, Texas, and South Georgia were major contributors to 2017 fire acreages.



## Summary of Fire Activity by State




## Year End Totals by Cause




Human Caused Fire by Agency




Human Caused Fire Acreage by Agency




Fire Causes in the Region



Lightning Caused Fire by Agency




Lightning Caused Fire Acreage by Agency



## Large Fire Activity Review

Per the National Mobilization Guide, a large fire is a wildland fire managed for complete perimeter control (Full Suppression) that is 100 acres or larger in timber fuel types and 300 acres or larger in grass or brush fuel types. There are other incidents that require ICS-209s, but the chart below includes only fires that were 1,000+ acres, and are sorted by start date of the incident due to the significant amount of 209 submissions for the year. There were 106 fires that exceeded 1,000 acres in 2017; 133 less than 2016.



During 2017, the dispatch community in the Southern Area entered 36,618 requests, and were able to fill 26,406 or approximately 72% of requests. There was a 7% decrease in orders filled from 2016. Only 265 orders were deleted. About 9% of the total orders were filled for FEMA hurricane response.

## Type 2 Incident Management Teams

Type 2 Incident Management Teams from the Southern Area were assigned for 88 days for preposition and wildfire support combined. The Southern Area mobilized 2 Type 2 IMT's for hurricane response for Texas, Puerto Rico, and the Virgin Islands for a combined 46 days. All out of Area Type 2 Incident Management Teams were assigned for a total of 101 days to assist with hurricane response efforts.



### South Central Compact




On March 7, 2017, the South Central Forest Fire Compact State Forester was activated at the request of Oklahoma State Forester George Geissler. Cooperation among the states was outstanding and ten different states responded to the need. **A total of 101 personnel were deployed.**

Conditions in Oklahoma improved in April and the Compact was closed on April 18, 2017.

### Southeastern Compact

As the fire situation was ongoing in Oklahoma, the Southeastern Forest Fire Compact was activated at the request of State Forester Jim Karels of Florida on March 23, 2017 due to their fire situation. The Compact was closed on June 17<sup>th</sup>.

**A total of 33 personnel were deployed.**
